Vulcan Tire Extended TPMS Warranty

WHO BENEFITS FROM THIS WARRANTY?

This warranty applies only to the original purchaser (or owner) named on the front of this certificate. This warranty provides the purchaser with the coverage detailed below only for the TPMS parts bearing the serial numbers listed on the front of this certificate. This warranty must be purchased within 14 days of the original purchase of the items it covers. In some cases, this warranty may be provided free of charge at the time of purchase of the items it covers.

WHAT IS COVERED AND FOR HOW LONG?

Regardless of the number of miles on the TPMS parts, the parts will be covered for a period of 12 months following expiration of the original manufacturer's warranty. See the "coverage period" listed on the front of this certificate. In the event a TPMS part listed on the front of this certificate becomes unserviceable due to a manufacturer defect during the "coverage period" listed on the front of this certificate, Vulcan Tire Sales will (at its sole discretion) repair or replace the item free of charge. This includes free ground/1st class shipping up to \$3.50, per incident.

Any repaired or replacement TPMS parts shipped to the customer under the terms of this warranty shall be covered by this warranty for the remainder of the coverage period, if any.

HOW DO I GET MY TPMS PART REPAIRED OR REPLACED?

Visit our website at: vulcantire.com/tpmswarranty.htm. From this webpage submit your warranty claim request. We will respond to your request via email within one business day. If your request is consistent with the terms stated in the "What is covered and for how long?" section above we will provide return information**. (shipping of the problem TPMS parts will be at the owners expense). The TPMS parts must pass inspection per the "What is not covered?" section below in order for a repair to be performed or replacement issued.

** The date you successfully submit your warranty claim request on our website will be considered the official date of your claim. All warranty coverage will be determined based on this date.

WHAT IS NOT COVERED?

Coverage does not apply to any claims arising from misuse, abuse, unauthorized repair or alteration, circumstances where the TPMS parts are improperly installed or improperly wired contrary to manufacturer product instructions; or TPMS parts exhibiting tool marks; or damage or defect attributable to fire or other casualty, including, without limitation, acts of God or exposure to abrasive or corrosive materials or pollutants, or attributable to collision or other accidents involving vehicles upon which the TPMS part is installed.

Coverage excludes TPMS parts with missing, damaged, defaced, altered or unreadable serial numbers. Coverage excludes TPMS accessories including but not limited to power cords, display mounts, fuses, etc.

Coverage excludes any TPMS part installed on a vehicle or equipment used in the following applications: Any emergency service; commercial towing, construction or postal service; farm, ranch, agriculture, mining or off-road use; racing, auto-cross, contests of speed or timed competition event. Any application where the TPMS parts are submerged in liquid.

Coverage excludes any additional fees or charges including but not limited to installation and taxes. Coverage excludes internal TPMS sensors or large bore TPMS sensors.

To the extent permitted by law, liability for consequential damages are disclaimed. In no case shall Vulcan Tire Sales' liability exceed the original cost of the purchased TPMS part. Some states do not allow the exclusion or limitation of incidental or consequential damages, therefore such limitations may not apply to you. This warranty gives you specific legal rights; you may have other rights which vary from state to state.

CAN THIS WARRANTY BE CANCELED?

The owner of this warranty can cancel this coverage within 14 days of purchasing the warranty, provided no claims have been submitted. You have 14 days from the date of purchase to successfully submit and RMA request on our website to cancel this coverage. After 14 days no refunds will be given.
